**Take time to read the rules** for the pool and sport courts and view the various forms for items such as renting the clubhouse or a storage space, installing a satellite dish or a new deck, or any landscape changes near your villa, etc. All property outside your courtyard belongs to the HOA.

**Association Management:** The current association management company for Inland Greens is Premier. **Community Overview:** Inland Greens is a community of 192 villas and is located adjacent to Cedar Ridge, which is a community of 86 single-family patio homes. Both communities have their own separate Board of Directors and governing documents. These two communities are joined together under a separate association known as "Third Corp" (IG/CR, Inc.). The Board of Directors of "Third Corp" consists of members from each of the Inland Greens and Cedar Ridge Boards. Third Corp is responsible for all the common amenities such as the streets, perimeter fences, pool, clubhouse, sport courts, storage corrals, and other common areas/facilities. There are separate documents specifying the Rules and Guidelines for these Third Corp areas of responsibility (see our web site). A portion of your monthly dues funds the operation of Third Corp.

**Association Governing Documents:** There are three important governing documents for our community: the Declaration of Covenants with Amendments, the By Laws and IGHOA Rules and Regulations. **The IGHOA Rules and Regulations are very important for all residents and their guests!** They are available on our web site. Every new owner should have received a copy of the first two documents prior to closing on the purchase of your villa. Copies are available on our web site or from Premier, our property management company.
